Also mandatory for any upper-level student on academic probation who has not yet taken the course. Elective for all other students. Students with a cumulative GPA between 2.000 and 2.199 may take a maximum of 12 hours if they are required to take Legal Practice Skills during the fall semester of their second year. Students with a cumulative GPA between 1.800 and 1.999 who are required to take Legal Practice Skills in the fall semester of their second year may take more than 12 hours only with the permission of the Associate Dean for Academic Affairs.

\*\*[LAW-2002](#) mandatory for upper-level students on academic probation who have already taken or are not required to enroll in Legal Practice Skills.
